ENCA Position Statement 3/2009 on -

EC communication on Towards an EU strategy on invasive species¹

Introduction

Invasive alien species² which threaten biodiversity, i.e. other species, habitats and whole ecosystems substantially contribute to biotic homogenisation worldwide. Due to globalisation, they are one of the most important drivers of biodiversity loss for many countries not only in isolated ecosystems but often elsewhere. In addition, many invasive alien species cause serious economic damage and some of them directly affect human health. According to the respected climate changes scenarios, a lot of current and future invasive alien species would even benefit from rapidly changing environments. New data on the extent of biological invasions pose major regulator and political challenges to the European Community and pan-European institutions³.

Moreover, within Europe, there has been lack of strategic and comprehensive approach and cooperation at various levels.

EC communication on Towards an EU strategy on invasive species

Statement

Therefore ENCA

- welcomes the above document issued by the European Commission,
- supports the policy options C (comprehensive, dedicated EU legal instrument),
- considers the development of a EU Strategy on invasive alien species by 2010 as the appropriate response to the serious issue,
- suggests to include in this strategy the EU Black List of Invasive Alien Spe-
- recommends the use of modern information technologies including internet for an effective information system on IAS for early warning and rapid response.
- urges the European government to implement the European Strategy on Invasive Alien Species adopted by Parties to the Convention on the Conservation of European Wildlife and Natural Habitats (the Bern Convention) in 2003 and also covering European countries outside the European Union.
